

Queen Alia International Airport welcomes over 900,000 passengers in July 2018

According to statistics released by Airport International Group, Queen Alia International Airport (QAIA) welcomed 918,207 passengers (PAX) in July 2018 - as opposed to 868,614 in the same month last year - marking a significant increase of 5.7% and setting an unprecedented record for previous July results. During the same period, aircraft movement (ACM) figures also rose by 6.3%, with handled cargo witnessing a decrease of 11.8%.

Ritz-Carlton Residences project in Jordan to launch in 2020

Minister of State for Investment Affairs Muhannad Shehadeh, who is also chairman of the Jordan Investment Commission (JIC), on Sunday checked up on the Ritz-Carlton Residences Project in Amman, where he said that improving the investment environment of the Kingdom is a "top priority" for the government, according to a JIC statement. Al Eqbal Real Estate Development CEO Imad Kilani, noted that the project will generate more than 1,300 jobs during the construction phase and 530 permanent jobs once completed. According to Kilani, the project is expected to launch in 2020, and will feature 90 private residencies.

UNRWA chief defends refugee criteria for millions of Palestinians

Millions of Palestinian refugees "cannot simply be wished away", the head of a U.N. support agency said on Monday, hitting back at a U.S. aid cutoff and allegations its work only perpetuates their plight. The United Nations Relief and Works Agency (UNRWA) provides services to about 5 million Palestinian refugees across Jordan, Lebanon, Syria and the West Bank and Gaza. Most are descendants of some 700,000 Palestinians who were driven out of their homes or fled fighting in the 1948 war that led to Israel's creation.
